## FLORIDA PUBLIC UTILITIES COMPANY'S PETITION FOR APPROVAL OF FUEL ADJUSTMENT AND PURCHASED POWER COST RECOVERY REVISED ESTIMATED/ACTUAL TRUE-UP AMOUNT

Florida Public Utilities Company (FPUC or Company), by and through its undersigned counsel, hereby files this Petition asking the Florida Public Service Commission (FPSC or Commission) for approval of FPUC's fuel adjustment and purchased power cost recovery revised estimated true-up amount for the period January 2012 through December 2012. In support of this request, the Company hereby states:

1) FPUC is an electric utility subject to the Commission's jurisdiction. Its principal business address is:

3) Consistent with the requirements for this proceeding, the Company has prefiled the fuel adjustment and purchased power cost recovery true-up forms supplied by the Commission consistent with the requirements for such filings.

- 4) In accordance with Order No. PSC-12-0061-PCO-EI, issued February 10, 2012, in this Docket, the Company submitted, on August 1, 2012, the Direct Testimony and Exhibit CDY-2 of Mr. Curtis Young in support of the Company's request for approval of the requested actual/estimated true-up amount.
- 5) The Company now finds it necessary to revise its estimated/actual true-up amount to reflect fuel savings experienced by the Company as a result the Commission's approval on July 2, 2012, of Gulf Power Company's mid-course reduction. These savings impacted only the Company's Northwest Division; thus, the Company is submitting, contemporaneously with this Petition, the Revised Testimony of Mr. Curtis D. Young, along with a Revised CDY-2, which includes the corrected amounts pertinent to the Northwest Division.
- 6) The final true-up amounts for the period January 2011 through December 2011 are an under-recovery of \$1,316,601 for the Marianna Division, and an under-recovery of \$545,737 for the Fernandina Beach Division.
- 7) The estimated true-up amounts for the period January 2012 through December 2012 are an <u>under-recovery of \$187,139</u> for the Marianna Division, and an over-recovery of \$801,347 for the Fernandina Beach Division.
- 8) The Company's total true-up amounts that would be collected or refunded during the period January 2013 through December 2013 are an <u>under-recovery of \$1,503,740</u> for the Marianna Division, and an over-recovery of \$255,610 for the Fernandina Beach Division.
- 9) In addition, the Company is also submitting a new Exhibit to Mr. Young's testimony for Commission consideration. Exhibit No. CDY-3 reflects the Company's fuel factor calculations with an underlying assumption that the Commission's Orders in Dockets

Nos. 100459-EI and 110041-EI, which are currently being appealed by the City of

Marianna, are ultimately upheld, in which case Gulf Power Company would bill the

Company in accordance with Amendment No. 1 to the Generation Services Agreement

("PPA") between Gulf Power Company and FPUC. Exhibit CDY-2 reflects that Gulf

Power is currently billing FPUC under the prior, unamended iteration of the PPA, per

agreement, in light of the ongoing legal proceedings. FPUC offers Exhibit No. CDY-3 in

support of a possible expedited mid-course correction should the Supreme Court affirm

the Commission's Orders in the referenced Dockets, thereby enabling FPUC and Gulf

Power to resume performance under Amendment No. 1 to the PPA. As reflected in that

Exhibit, the total true-up amount to be collected in 2013 would change to an over-

recovery of \$3,248 for the Northwest Division, based upon six months of actual data and

six months of estimated data, and assuming reinstatement of Amendment No. 1.

WHEREFORE, FPUC respectfully requests that the Commission approve the Revised

estimated true-up amounts for January 2012 through December 2012.
