

SEPTEMBER 25, 2012

On October 3, 2011, Regency Utilities, Inc. (the "Utility"), filed its application to the Florida Public Service Commission (the "Commission") for Staff Assisted rate Case to increased water and wastewater service rates.

By Proposed Agency Action Order No. PSC-12-0436-PAA-WS ("PAA Order"), issued August 24, 2012, the Commission proposed a revenue increase of 65.78% for water service and 56.93% for wastewater service. These increases were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service.

The increased rates and charges are effective for service on or after October 1, 2012.

The rates prior to filing and the Commission-approved water and wastewater rates are attached to this customer notice. The Commission also authorized the Utility to collect customer deposits, and impose other service charges as set forth below.

This notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its customers.
