collected during the period of January 2013 through December 2013?

SJNG's Position: \$49,289 over-recovery.

Issue #4: What is the appropriate levelized purchased gas adjustment
recovery (cap) factor for the period January, 2013 through December 2013?
SJNG's Position: .701 cents per therm recovery (cap) factor
