Qwest Communications Company, LLC d/b/a CenturyLink QCC (“QCC”), by and through its undersigned counsel, hereby files this voluntary dismissal with prejudice of its claims in this Complaint against Deltacom, Inc. (“Deltacom”) and Saturn Telecommunication Services, Inc. d/b/a Earthlink Business (“Saturn”). QCC files this voluntary dismissal of Deltacom and Saturn based on QCC’s and Saturn’s and Deltacom’s execution of a Confidential Settlement Agreement and Release, included with this Notice as Exhibit A.¹ The Agreement resolves the issues raised by QCC in its Amended Complaint as they relate to Deltacom and Saturn.
