

**LTS OF ROCKY MOUNT, LLC'S REQUEST FOR

LTS of Rocky Mount, LLC (LTS), pursuant to rule 25-22.006, Florida Administrative Code, requests confidential classification for certain information contained in LTS' response to the Commission's General Data Request to LTS dated September 19, 2012. As grounds therefor, LTS states:

1. On July 24, 2012, LTS filed an Application for Authority to Provide Competitive Local Exchange Telecommunications Company Service.

2. On August 2, 2012, AT&T filed a Response in Objection to LTS' Application for Authority to Provide Competitive Local Exchange Telecommunications Company Service.

3. On September 19, 2012, the Commission Staff from the Office of Telecommunications sent LTS a General Data Request.

4. Section 364.183(3), Florida Statutes, provides that:

The term "proprietary confidential business information" means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the persons or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that that provides that the information will not be released to the public.

5. Exhibit A to this request is a matrix providing justification and support for confidential classification of the highlighted information within LTS' response to the


