Dear Ms. Cole:

NextG Networks of NY, Inc. dba NextG Networks East ("NextG-NY") hereby notifies the Florida Public Service Commission ("Commission") of its name change to Crown Castle NG East Inc.

NextG-NY was authorized to provide competitive local exchange telecommunications services and alternative access services pursuant to Orders PSC-04-0907-CO-TX and PSC-04-0908-CO-TA issued September 24, 2004. In February 2012, NextG-NY informed the Commission of its proposed transfer of control to Crown Castle Solutions Corp. The transfer was consummated in April, 2012.

The purpose of NextG-NY's name change is to enable it to align its legal name with how it is identified, and recognized by, its customers and the general public. The requested name change exclusively relates to a legal name change and is not sought in conjunction with any merger, acquisition, consolidation or other change in corporate structure or ownership that would require separate Commission authority.




1. This corporation's name is Crown Castle NG East Inc. (the "Company").
