Dear Ms. Cole:

On October 31, 2012 we submitted for filing on behalf of Tampa Electric Company revised redacted versions of two Bates stamped pages previously identified as Bates stamped pages 84 and 85. Those pages were revised to reflect that they were in response to Interrogatory No. 50, rather than Interrogatory No. 60, and were also re-Bates stamped pages 73A and 73B, to be substituted behind Bates stamped page 73 in place of the earlier filing marked Bates stamped pages 84 and 85.

Staff has requested that we resubmit a single revised confidential version of each of pages 73A and 73B with the yellow highlighting removed from the three commodity columns on those pages, to reflect the fact that we are withdrawing our request for confidential treatment of those commodity prices.
