Re: Request of 360networks (USA) inc. to Surrender its Authorizations

Dear Ms. Cole:

360networks (USA) inc. ("360networks"), by its undersigned counsel, hereby voluntarily surrenders its CLEC Certificate No. 7665 and any authorization to provide interexchange services (360networks formerly held IXC Certificate No. 7297) (the "Authorizations"). 360networks, therefore, requests that the Commission cancel 360networks' Authorizations and withdraw all tariffs on file with the Commission, effective immediately or as soon as the Commission can take such action.

360networks does not provide intrastate telecommunications services in Florida and has no plans to do so in the future. 360networks, therefore, no longer requires its Authorizations. Because 360networks does not serve any customers or have any active telecommunications operations in Florida, 360networks respectfully submits that the surrender of its Authorizations and withdrawal of its tariff(s) is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.


