**Re: Request of AboveNet Communications, Inc. to Surrender its Authorizations**

Dear Ms. Cole:

AboveNet Communications, Inc. ("AboveNet"), by its undersigned counsel, hereby voluntarily surrenders its CLEC Certificate No. 7124 and any authorization to provide interexchange services (AboveNet formerly held IXC Certificate No. 7157) (the "Authorizations").<sup>1</sup> AboveNet, therefore, requests that the Commission cancel AboveNet's Authorizations and withdraw all tariffs on file with the Commission, effective immediately or as soon as the Commission can take such action.

AboveNet does not provide intrastate telecommunications services in Florida and has no plans to do so in the future. AboveNet, therefore, no longer requires its Authorizations. Because AboveNet does not serve any customers or have any active telecommunications operations in Florida, AboveNet respectfully submits that the surrender of its Authorizations and withdrawal of its tariff(s) is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.


