MOTION FOR STAY PENDING JUDICIAL REVIEW

Petitioner, Edward McDonald, moves for a STAY PENDING JUDICIAL REVIEW of its decision rendered on December 10, 2012, denying movant's REQUEST FOR RECONSIDERATION asking that an alleged bill that is seven years old be barred by the Statute of limitations (F.S. 95.11 and the responses of Respondent be stricken for untimely filing pursuant to F.A.C. RULE 25-22.060 (1)(d),(2)&(3).

The order is appealed under F.S. 120.68 RE F.A.C. RULE 25-22.061 1(a). "The order appealed involves refund of money to customers".

THIS APPEAL WILL BE FILED IN THE COURT OF APPEALS OF FLORIDA - SECOND DISTRICT in the time and manner prescribed by FLORIDA RULES OF APPELLATE PROCEDURE.
