

2. I have personal knowledge of the matters stated in this Affidavit.

3. I am an attorney, admitted to the practice of law in the State of Utah and in the State of Oregon. I have practiced extensively before the Public Utility Commission of Oregon and the Utah Public Service Commission, in matters relating to the regulation of electric utilities. I have made appearances and participated in numerous regulatory proceedings. Such proceedings include general rate cases and rate mechanisms, as well as proceedings involving, among other subjects, qualified facility interconnections, renewable portfolio standards, generation resource

planning and acquisition, affiliate transactions and pole attachments. I also have made appearances or participated in rulemaking and other proceedings before the California Public Utilities Commission, California Energy Commission, California Air Resources Board, Idaho Public Utilities Commission, Washington Transportation and Utilities Commission and the Wyoming Public Service Commission.

4. Since 2011, I have served as a Florida Authorized House Counsel. From 2011 to present, I have represented FPL before the Florida Public Service Commission, which has jurisdiction with respect to electric and other utilities in the State of Florida. My work has included representing FPL in general rate proceedings, rulemakings, and other electric utility matters.



7. I have reviewed Rule 28-106.107 of the Florida Administrative Code and agree to abide by its standards.


