- 2. I have personal knowledge of the matters stated in this Affidavit.
- 3. I am an attorney admitted to practice law and in good standing in the State of Illinois since 1986. From 1989 to 2005, I represented a major Illinois electric utility company before the Illinois Commerce Commission, which has jurisdiction with respect to electric and other utilities in the State of Illinois. My work included providing representation in rate proceedings, delivery service proceedings, fuel clause reconciliations, utility tariff and special contract matters, rulemakings and a variety of other electric utility cases.

- 4. Since 2005, I have served as a Florida Authorized House Counsel. From 2005 to present, I have represented FPL before the Florida Public Service Commission, which has jurisdiction with respect to electric and other utilities in the State of Florida. My work has included representing FPL in general rate proceedings, storm cost recovery proceedings, generating plant need determinations, petitions for financing authority, rulemakings, and other electric utility matters.

I have experience and am familiar with the Florida Statutes relating to the jurisdiction of the Florida Public Service Commission, and the Florida Rules of Civil Procedure relating to discovery in an administrative proceeding.
