


**REQUEST FOR NAMING OF BRYAN S. ANDERSON AS

1. My name is Bryan S. Anderson. I am employed by Florida Power & Light Company ("FPL") as Assistant General Counsel - Regulatory. My business address and telephone number are as follows:

2. I have personal knowledge of the matters stated in this Affidavit.

3. I am an attorney admitted to practice law and in good standing in the State of Illinois since 1986. From 1989 to 2005, I represented a major Illinois electric utility company before the Illinois Commerce Commission, which has jurisdiction with respect to electric and other utilities in the State of Illinois. My work included providing representation in rate proceedings, delivery service proceedings, fuel clause reconciliations, utility tariff and special contract matters, rulemakings and a variety of other electric utility cases.

4. Since 2005, I have served as a Florida Authorized House Counsel. From 2005 to present, I have represented FPL before the Florida Public Service Commission, which has jurisdiction with respect to electric and other utilities in the State of Florida. My work has included representing FPL in general rate proceedings, storm cost recovery proceedings, generating plant need determinations, petitions for financing authority, rulemakings, and other electric utility matters.

I have experience and am familiar with the Florida Statutes relating to the jurisdiction of the Florida Public Service Commission, and the Florida Rules of Civil Procedure relating to discovery in an administrative proceeding. I also have experience and am familiar with portions of the Florida Administrative Code and Florida Statutes relative to the rules of evidence, including the concept of hearsay in an administrative proceeding.

6. I have been certified by the Supreme Court of Florida as “Authorized House Counsel” pursuant to Chapter 17 of the Rules Regulating the Florida Bar. Accordingly, I am subject to the Rules Regulating the Florida Bar and to the jurisdiction of the Supreme Court of Florida for disciplinary purposes.


7. I have reviewed Rule 28-106.107 of the Florida Administrative Code and agree to abide by its standards.
