Ms. Krasley,

The Clerk's office forwarded your emails to my attention because the company is no longer providing services in Florida. Unless Shentel Converged Services, Inc. d/b/a NTC Communications/TS213 is no longer providing services in Florida you will continue to receive Florida Commission emails.

Now is a perfect time to request voluntary cancellation of the STS certificate, pay the 2012 minimum Regulatory Assessment Fees (RAF) if your revenue meets the minimum calculated on the RAF form. Once you request cancellation in writing and pay the 2012 RAF due early, I can open a docket and process canceling the STS Certificate effective December 31, 2012 or sooner depending on the date of your request.

I will email a 2012 RAF form to your attention in a separate email.

Call me if you have any questions.

If you don't want to cancel the STS certificate, I will direct the Clerk's office to send Commission emails to your email address only until the company decides to cancel its Florida certificate.
