Dear Ms.Cole:

Bright House Networks Information Services (Florida), LLC ("BHN") and Telovations Inc. ("Telovations") (referred to jointly herein as "Parties"), hereby notify the Commission that the above-referenced transaction, as previously described in BHN's letter of November 19, 2012, to the Commission, was consummated on December 31, 2012. Consistent with the transaction as anticipated in that November 19, 2012, letter, BHN has acquired Telovations (Certificate No. 8653) through the purchase of all assets, including Telovations's customer base.

Consistent with the closing of the transaction, the Parties ask that Telovations's contact information on file with the Commission be amended such that the registered address for Telovations is made consistent with that listed for BHN, which is:

As noted previously, this transaction will be largely transparent to customers of Telovations. Specifically, they will see no immediate change to their service offerings, rates, or terms of service, and service will continue to be provided, for the time being, under the Telovations name.
