Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Progress Energy Florida requests confidential classification of certain highlighted information provided in its Revised August, 2012 Form 423 Fuel Report. This document is a substitution for the August, 2012 Form 423 Fuel Report identified as Document No. 06736-12, which was filed on October 4, 2012. The Revised version was filed on December 7, 2012.
