

On May 9, 2012, Utilities, Inc. of Pennbrooke (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased water and wastewater service rates, in which it requested a permanent increase for its water system in Lake County of 33.02% and an increase for its wastewater system in Lake County of 23.78%.

By Proposed Agency Action Order No. PSC-12-0667-PAA-WS ("PAA Order"), issued December 26, 2012, the Commission approved a rate increase of 0.95% for water service and 11.56% for wastewater service. These rates were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service. The PAA Order was not protested within the protest period, and became final by Order No. PSC-13-0041-CO-WS, issued January 22, 2013.

The increased rates and charges are effective for service on or after January 30, 2013.

The rates prior to filing, and the Commission-approved water and wastewater rates are attached to this customer notice.

This notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its customers.
