Subject: Request of Oral Modification to Item 10, March 5, 2013 Agenda, Docket No. 130019-EI – Petition for approval of revised lighting tariffs by Tampa Electric Company.

Staff requests approval to make an oral modification to replace Attachment A of the recommendation for the above-referenced item with the attached sheet. Staff inadvertently attached the originally filed tariff sheet to the recommendation. Staff's discussion with the utility resulted in identification of some errors the utility made in calculating the maintenance rates to be charged. Tampa Electric subsequently filed a revision to the tariff sheet with corrections made to the maintenance charges (3rd to last column). All other charges are unchanged. The attached corrected tariff sheet should replace the current sheet at Attachment A. This correction does not change staff's recommendation.

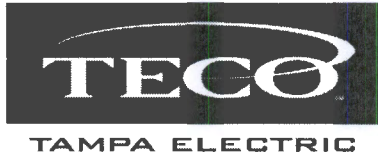
