AT&T plans to discontinue offering this service on or after June 30, 2013, subject to Commission approval of this Application.

**Points of Geographic Areas of Service Affected (47 C.F.R. § 63.71(a)(3), b(2)):**

FGC service will be discontinued in Alabama, Arkansas, Florida, Georgia, Illinois, Indiana, Kansas, Kentucky, Louisiana, Michigan, Mississippi, Missouri, Nevada, North Carolina, Ohio, Oklahoma, South Carolina, Tennessee, Texas and Wisconsin.

**Brief Description of Type of Service Affected (47 C.F.R. § 63.71(a)(3), b(2)):**

Feature Group C service (FGC) is a trunk side switched access service provided by using end office or access tandem switch trunk equipment. The switch trunk equipment is provided with answer and disconnect supervisory signaling. This service is offered in the following interstate switched access tariffs:

Bellsouth Telecommunications Tariff F.C.C. No. 1  
Ameritech Operating Companies Tariff F.C.C. No. 2  
Nevada Bell Telephone Company Tariff F.C.C. No. 1  
Southwestern Bell Telephone Company Tariff F.C.C. No. 73

AT&T is discontinuing this service because there is no market demand. The public convenience and necessity is not impaired by the discontinuance of FGC service because Feature Group D (FGD) service has become the standard service used for trunk-side switched access.

**Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R. §63.71(b)(3)):**

AT&T has no customers using FGC service.

Copies of this Application are being sent, first class U.S. Mail, to the public utilities commission and governor of each state in which discontinuance is proposed and also to the Special Assistant for Telecommunications to the Secretary of Defense, as required by 63.71(a) of the Commission's rules.
