Since no protest was received by the close of business on June 14, 2002, your certificate to operate as an alternative local exchange service company (ALEC) became effective on June 17, 2002, in Docket No. 020270 TX, Order Number PSC-02-0711-PAA-TX and Consummating Order Number PSC-02-0836-CO-TX.

If you intend to offer basic local service, a price list must be submitted to the Commission at least one day prior to offering service. The price list must include service quality standards for the following categories:
