2 **CHAIRMAN BRISÉ:** We will officially call this
3 meeting to order at this time, and recognizing that
4 today is the 20th take our daughters and sons to work
5 day. And our theme this year, I guess the national
6 theme is work in progress. So we have some future
7 workers that are here today, and they are here in the
8 audience, so if we have all the young people stand. And
9 they represent the future of not only this agency but

8 **COMMISSIONER EDGAR:** Mr. Chairman, I
9 understand that we have an oral modification on Item 3.

10 **MS. BRUCE:** Yes. Commissioners, Sonica Bruce.
11 Commission staff has on oral modification on Page 34 of
12 the recommendation at the bottom of the page. In the
13 section titled wastewater service availability charges,
14 the plant capacity charge should be \$765 per ERC for
15 residential customers and \$2.83 for all others. The
16 main extension charge should be \$2,268 per ERC for
17 residential customers and \$8.40 for all others. Thank
18 you.

19 **COMMISSIONER EDGAR:** Mr. Chairman, if
20 appropriate I would move the staff recommendation for
21 Items 1, 3 as modified, 4, 5, 6, 7, and 8.

22 **CHAIRMAN BRISÉ:** Thank you.

23 It has been moved and seconded. Is there any
24 further discussion or comments on any of these items?

25 Okay. Just a quick comment on Items 7 and 8,


