AMENDATORY ORDER

BY THE COMMISSION:

On May 2, 2013, the Commission issued Order No. PSC-13-0187-PAA-WS granting an increase in water and wastewater rates for Pluris Wedgefield, Inc. However, due to a scrivener's error, Tables 12 and 13 reflect incorrect rate factors and figures. Therefore, Order No. PSC-13-0187-PAA-WS is amended to replace Tables 12 and 13 with the following:
