**FLORIDA POWER & LIGHT COMPANY'S
REVISED REQUEST FOR CONFIDENTIAL CLASSIFICATION
OF EXHIBITS TOJ-13 AND SDS-7**

Pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") requests confidential classification of portions of Exhibit TOJ-13 to the testimony of FPL witness Terry Jones and Exhibit SDS-7 to the testimony of FPL witness Steven D. Scroggs. In support of its request, FPL states:

1. On May 1, 2013, FPL filed a Request for Confidential Classification of a portion of Terry Jones's May 1, 2013 testimony as well as portions of Exhibits TOJ-13 and SDS-7. FPL is filing this Revised Request for Confidential Classification to limit its requested confidential treatment to Exhibits TOJ-13 and SDS-7.

2. The following exhibits are included with and made a part of this request:

a. Revised Exhibit A consists of a copy of the confidential pages on which all information that FPL asserts is entitled to confidential treatment has been highlighted.

b. Revised Exhibit B consists of a copy of the confidential pages on which all information that FPL asserts is entitled to confidential treatment has been redacted.

c. Revised Exhibit C is a table containing an identification of the information highlighted in Exhibit A, together with references to the specific statutory basis or bases for the claim of confidentiality and to the affidavit in support of the requested classification.

d. FPL incorporates herein by reference Exhibit D included with its May 1, 2013 Request for Confidential Classification.

4. FPL submits that the highlighted information in Exhibit A is proprietary confidential business information within the meaning of Section 366.093(3), Florida Statutes. Section 366.093(3), Florida Statutes, defines confidential information as information that is intended to be and is treated by the company as private in that disclosure of the information would cause harm to the company's business operations or its customers, and has not been disclosed publicly. The confidential information is intended to be and has been treated by FPL as private, its confidentiality has been maintained, and its disclosure would cause harm to FPL and its customers. Pursuant to Section 366.093(3)(2), such information is entitled to confidential treatment and it is exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information

4. As the affidavits included in Exhibit D indicate, the information provided by FPL in Exhibits TOJ-13 and SDS-7 contains contractual data, the public disclosure of which would violate nondisclosure provisions of FPL's contracts with certain vendors and impair FPL's ability to contract for goods or services on favorable terms in the future. Such information is protected by Section 366.093(3)(d), Florida Statutes. Additionally, this information is competitively sensitive, and disclosure could impair the competitive business of FPL or its vendors. Such information is protected by Section 366.093(3)(e), Florida Statutes.

5. Upon a finding by the Commission that the information highlighted in Revised Exhibit A, and referenced in Revised Exhibit C, is proprietary confidential business information,

the information should not be declassified for a period of at least eighteen (18) months and should be returned to FPL as soon as the information is no longer necessary for the Commission to conduct its business. *See* § 366.093(4), Fla. Stat.

WHEREFORE, FPL respectfully requests confidential classification of the material described herein.
