

Tampa Electric Company ("Tampa Electric" or "the company") hereby withdraws its Request for Confidential Classification and Motion for a Temporary Protective Order ("request and motion") filed June 17, 2013 in this proceeding and, says:

1. The company's July 17 request and motion sought confidential treatment of Bates stamp pages 12-14 contained in the company's response to the Staff's Amended Second Request for Production of Documents (No. 27).
2. The company has since determined that it no longer requires confidential treatment of the information contained in that filing.


