On June 21, 2013, Florida City Gas (FCG) filed its request for confidential classification for Document No. 03494-13. This document is a response to a staff data request regarding a special gas transportation agreement between FCG and the Miami-Dade Water and Sewer Department (MDWASD). The information in the document for which FCG seeks confidential treatment relates to projected contributions to FCG's common costs and to customer-specific operating and depreciation expenses. Staff has reviewed the document and concurs with FCG that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm FCG's competitive business operations.

Therefore, staff recommends that FCG's request for confidential classification of Document No. 03494-13 be approved.
