Dear Ms. Cole,

This letter is the response of Consolidated Services of Hendry & Collier, LLC ("Consolidated Services") to Tom Ballinger's letter of May 28, 2013. The Commission voted, on June 25, 2013 to grant the applicant a temporary waiver of Rules 25-30.033(1)(h), (m), (o), (t), (u), (v) and (w). Those are the Rules referenced in numbered paragraphs (1) and (4)-(9). We assume that Commission action addresses the staff's concerns as to those specific rule requirements.

In reference to paragraph (2) and the requirements of Rule 25-30.033(1)(j), the lessor, the owner of the land to be certificated, and the lessee, the Utility, are uniquely situated to comply with a 30 day time frame required by Commission Rule. On behalf of the landowner and the Applicant, please accept this representation that the 30 day timeframe for execution of the water and wastewater lease agreements will be met, and that the appropriate resources of both the landowner and the utility will be brought to bear such that the timeframe will be achieved.

As to paragraph (3), Rule 25-30.033(1)(k) provides that the rates and charges of the water or wastewater system should be set forth in the sample tariffs submitted with the application. In this instance, the water or wastewater system will have no authorized rates or charges at the time of certification. Supplemental tariffs will be filed at the appropriate time consistent with the Commission's rules and the variance which the Commission granted on June 25, 2013.

With regard to the registration of the Applicant with the Florida Department of State, Division of Corporations, enclosed please find proof of registration.
