On behalf of TNCI Operating Company LLC ("TNCI-OpCo") and Trans National Communications International, Inc. (Debtor-In-Possession) ("TNCI-DIP") (together, the "Parties"), this letter notifies the Commission that on June 21, 2013, TNCI-OpCo completed the acquisition of the Florida customers (including the customers' contracts) and assets of TNCI-DIP as described in the above-referenced Notification.
