Dear Ann:

On April 1, 2013, the Commission opened Docket No. 130091-EI, to address a petition filed by Duke Energy. In response, the Commission approved a regulatory asset by Order no. PSC-13-0381-PAA-EI and the order became final on September 6, 2013.

On August 1, 2013, Duke filed a Petition for limited proceeding to approve revised and restated stipulation and settlement agreement by Duke Energy Florida, Inc. d/b/a Duke Energy. This petition was assigned Docket No. 130208-El. It is a global settlement of many issues and dockets, and involves many parties.

After receiving the global settlement, I requested that the August 1 petition be filed in all dockets named in the global settlement. The notice of hearing for the global settlement was also filed in all of the dockets named in the August 1 petition.

Staff has been asked to write a memo to reopen Docket No. 130091-EI because of the global settlement. Staff believes Docket No. 130091-EI should remain closed because all issues concerning Docket No. 130091-EI have been resolved and the PAA order is now final. Any action the Commission takes on the global settlement should have no impact on Order no. PSC-13-0381-PAA-EI.
