October 17, 2013, has also been reserved for continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded. At that time, the Commission may render a bench decision. If no bench decision is rendered following the conclusion of all testimony being entered into the record, the Commission will hold a Special Agenda Conference to render a decision on Thursday, October 24, 2013.

Persons wishing to present oral evidence or argument will be given the opportunity to do so at the beginning of the hearing on October 16, 2013. All persons wishing to present oral evidence or argument are urged to be present at the beginning of the session, since the session may be adjourned early if no persons are present. By providing oral evidence or argument, a person does not become a party to the proceeding. To become an official party of record, you must file a Petition for Intervention at least five days before the final hearing pursuant to the requirements contained in Rule 25-22.039, Florida Administrative Code.

PURPOSE AND PROCEDURE

The purpose of this hearing is to consider Duke Energy Florida, Inc.'s Petition for Limited Proceeding to Approve Revised and Restated Stipulation and Settlement and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. The Commission's decision in this matter may result in an increase to customers' rates. 
JURISDICTION
