Docket No. 080271-EI was opened to monitor the status of joint ownership discussions associated with Florida Power & Light's ("FPL's") Turkey Point Units 6 & 7, as directed in Order No. PSC-08-0237-FOF-EI, issued April 11, 2008.

By Order No. PSC-08-0237-FOF-EI, the Commission approved a stipulation which states in relevant part: "No later than July 1, 2009, FPL will continue its good faith discussions with FMEA, FMPA, and OUC, and will also commence good faith discussions of joint participation in Turkey Point Units 6 & 7 with JEA and Seminole. FPL will report the status of such ongoing status discussions to the FPSC every quarter thereafter."

As required by Order No. PSC-08-0237-FOF-EI, FPL has continued good faith discussions with the Florida Municipal Energy Association ("FMEA"), Florida Municipal Power Agency ("FMPA"), Orlando Utilities Commission ("OUC"), JEA, and Seminole Electric Cooperative, Inc. ("Seminole"). In August, FPL and FMPA discussed the potential to enter into an option agreement for FMPA participation in Turkey Point 6 & 7. No such agreement has been reached, and no other activity has occurred since that reported in FPL's last quarterly report filed July 1, 2013.
