Enclosed for filing on behalf of Florida Power and Light Company ("FPL") and the Peace River Electric Cooperative, Inc. ("PRECO") is a redacted second revised version of Exhibit B to FPL and PRECO's Joint Petition for Approval of Transfer of Customers filed on October 23, 2013. The original Exhibit B submitted on October 23, 2013, inadvertently included confidential information which should have been redacted. On October 24, 2013, FPL submitted a revised version of Exhibit B in redacted form and requested the return of the original Exhibit B. On October 28, 2013, the Commission returned the original Exhibit B to FPL.

FPL has identified errors in the customer account types and dates of notification for affected customers of FPL and PRECO provided in the revised Exhibit B submitted on October 24, 2013. The enclosed redacted second revised version of Exhibit B correctly identifies the customer account types and dates of notification for affected customers. In addition, the enclosed redacted second revised version of Exhibit B identifies an additional date of notification for the PRECO Affected Customer. That additional notification corrected an error in the first notification, and included a bill comparison.

FPL's original Notice of Intent to Request Confidential Classification of Exhibit B was submitted on October 23, 2013. The deadline to request confidential classification is November 13, 2013. FPL will provide the unredacted second revised version of Exhibit B along with a Request for Confidential Classification by that date.

Additionally, in describing the affected customers referenced in Exhibit B, the Joint Petition for Approval of Transfer of Customers submitted on October 23, 2013, at paragraph 11, states, "Of the three FPL Affected Customers to be transferred from FPL to PRECO, one is residential and two are commercial." That statement should be corrected to read, "Of the four FPL Affected Customer accounts to be transferred from FPL to PRECO, two are residential, one is commercial, and one is outdoor lighting."
