4 **MS. MATTHEWS:** Good morning, Commissioners.

5 Item 5 is Duke Energy Florida's request for approval of
6 an amendment to its standard offer contract to purchase
7 energy and capacity from renewable generators.

8 The Commission Rule 25-17.250 requires
9 utilities to amend their Standard Offer Contract upon
10 issuance of an RFP to build its next planned generating
11 unit, which is the avoided unit upon which the contract
12 payments are based.

13 Duke Energy Florida issued its RFP on October
14 8, 2013, the same date the petition in this docket was
15 filed. The new avoided unit is a 793-megawatt combined
16 cycle gas unit as shown -- and -- I'm sorry -- and staff
17 is recommending the approval.

18 **CHAIRMAN GRAHAM:** Thank you.

19 Commissioners, any questions or comments on
20 item number 5? Seeing none. Thank you, staff.
