Pursuant to Section 4.5.2 of AT&T Florida's Self Effectuating Enforcement Mechanisms Administration Plan ("Plan"), AT&T Florida hereby invokes a state wide Force Majeure Event effective January 28, 2014 in connection with the January 28-29, 2014 ice storm. The measures affected as a result of the force majeure event included all measures associated with Ordering<sup>1</sup>, Provisioning, Maintenance and Repair and Truck Group Performance.

For purposes of the Provisioning, Maintenance and Repair, and Trunk Group Performance Measures, AT&T Florida hereby submits the attached spreadsheet identifying all of the wire centers affected by this severe weather event, and AT&T Florida will notify the Commission when the emergency period is concluded.

For purposes of the Ordering Performance Measures, the impact will be region wide because the Local Service Center ("LSC") is located in Birmingham, AL, which was also hit with these winter storms. The Force Majeure is expected to resolve on February 5, 2014.
