<u>PREMISES VISIT CHARGE (IN LIEU OF DISCONNECTION)</u> —This charge may be levied when a service representative visits premises for the purpose of discontinuing service for nonpayment of s due and collectible bill and does not discontinue service because the Customer pays the service representative or otherwise makes satisfactory arrangements to pay the bill.

NON- SUFFICIENT FUNDS (NSF) CHARGES — This charge may be levied on all NSF charges pursuant to Florida Statute Chapter 832.
