
Dear Mr. Harris:

Please be advised the staff of the Florida Public Service Commission has opened a docket initiating show cause proceedings against Country Club Utilities, Inc. for violation of Commission rules and regulations. The proceedings are based upon Country Club's failure to submit its Regulatory Assessment Fees (RAFs) for the years 2010, 2011 and 2012, pursuant to Sections 350.113 and 367.145, F.S., and Rule 25-30.120, F.A.C.
