



Notice is hereby given on the 27<sup>th</sup> day of January, 2014, pursuant to Section 367.045, Florida Statutes, and Rule 25-30.030, Florida Administrative Code, of the Application for an amendment of Certificate No. 410-W in Highlands County, by Placid Lakes Utilities, Inc. The Applicant proposes to extend its existing certified water service area to include the following land in Highlands County, Florida.

**LEGAL DESCRIPTION:**

Township 37 South, Range 29 East

Section 13

All of said Section 13 lying South and West of Catfish Creek.

Section 24

All of said Section 24 lying South and West of Catfish Creek and West of Lake Placid, excluding the area south of a line described thusly:

Commence at the Southwest Corner of Section 24, Township 37 South, Range 29 East; thence run northerly along the West Section Line of said Section 24 for a distance of approximately 660 feet to the Point of the Beginning; thence run easterly until reaching Lake Placid.
