Based on our review of the company's calculations, staff believes that the requested rate of 6.47 is not appropriate due to a small rounding error in the company's calculation, and instead recommends that the 6.4 -- that 6.46 percent is the appropriate AFUDC rate. Tampa Electric Company has indicated to staff that it agrees with staff's adjustment, so staff is prepared to answer questions the Commission may have on this matter.
