MR. GARL: Commissioners, Item 15 is a petition from Peoples Gas System requesting approval of a special contract with RockTenn CP, LLC, for natural gas transportation service to paper products mills in Panama City, Jacksonville, and Fernandina Beach.

The staff recommendation requires an oral modification to correct a scrivener's error on page 3, second paragraph of the staff analysis section, line 5. The number 6.1 should be changed to 16.1, so it reads, "constructed a 16.1 mile, 12-inch pipeline." The proposed contract precludes potential bypass by RockTenn, establishes rates that cover the cost of service, and provides protection for Peoples and its general body of ratepayers. Staff recommends approval.
