2 **MS. WATTS:** Melinda Watts for staff.

3 Commissioners, Item 15 addresses Farmton's
4 request for amendments to its water and wastewater
5 service territories in Brevard and Volusia Counties.

6 Staff believes that the utility has satisfied
7 the requirements of Rule 25-30.036, and thus we
8 recommend that the utility should be granted the service
9 territory amended described in Attachment A.

10 There is an oral modification to this item
11 that was provided to your offices and all parties on
12 Friday. It is just to correct some minor scrivener's
13 errors and some headings in Attachment A.

14 Marty Deterding will be present -- he is
15 present representing Farmton and available to answer any
16 questions regarding the amendment.

17 In addition, staff is available to answer any
18 questions that you may have with respect to the
19 recommendation.
