**DUKE ENERGY FLORIDA, INC.'S CORRECTED SIXTH NOTICE OF INTENT  
TO REQUEST CONFIDENTIAL CLASSIFICATION**

On July 7, 2014, Duke Energy Florida, Inc. ("DEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, timely filed its Sixth Notice of Intent to Request Confidential Classification (Document No. 03509-14) of the confidential portions of DEF's Response to NRG Florida LP's First Request for Production of Documents (Nos. 1-17) and DEF's responses to NRG Florida LP's First Set of Interrogatories (Nos. 1-108). Exhibit A of that Notice inadvertently omitted the responsive documents to NRG Florida's First Request for Production request numbers 1 and 3. These documents contain proprietary confidential competitively sensitive business and contractual information the disclosure of which would adversely impact DEF's competitive business interests if disclosed and would violate contractual confidentiality provisions.

Attached as Corrected Exhibit A is a CD containing confidential, highlighted copies of the above referenced information and documents.

Pursuant to Rule 25-22.006(3)(a)(1), DEF will file its Request for Confidential Classification for such confidential information contained therein within twenty-one (21) days of filing this request.
