6 I'm Traci Matthews with staff.

7 Item 5 is the petition from Gulf Power Company
8 to update its annual standard offer contract and the
9 related rate schedule for the purchase of capacity and
10 energy from renewable generators.

11 As the Ten-Year Site Plans are updated
12 annually, the standard offer contracts are also updated
13 to reflect the changing next planned fossil-fueled
14 generating unit. This unit is used as the utility's
15 next avoided unit on which the contract payments are
16 based. The contract has been revised with the new
17 avoided unit and its in-service date, along with the
18 estimated payments based on that unit. Staff is
19 recommending approval of Gulf's petition.

20 **CHAIRMAN GRAHAM:** Thank you, staff.
