Calpine Construction Finance Company, L.P. ("Calpine"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files its Second Notice of Intent to Request Confidential Classification of the confidential portions of some of the documents produced by Calpine in response to Duke Energy Florida, Inc.'s ("DEF's") discovery requests in this docket. 
