**DUKE ENERGY FLORIDA, INC.'S FOURTEENTH NOTICE OF INTENT
 TO REQUEST CONFIDENTIAL CLASSIFICATION**

Duke Energy Florida, Inc. ("DEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files its Fourteenth Notice of Intent to Request Confidential Classification of the confidential portions of DEF's Responses to Staff's Second Set of Interrogatories to Duke Energy Florida, Inc. (Nos. 56-61) and DEF's Responses to Staff's Second Request for Production of Documents (Nos. 12-13). Specifically, portions of the documents responsive to interrogatory numbers 60 and 61 and portions of the documents responsive to request for production numbers 12 and 13 contain proprietary confidential business and contractual fuel forecast information the disclosure of which would adversely impact DEF's competitive business interests and potentially violate contractual confidentiality provisions.
