2           **CHAIRMAN GRAHAM:** On to item number 6.

3           **MR. CASEY:** Good morning, Commissioners. Bob  
4 Casey on behalf of staff.

5           Item number 6 is staff's recommendation to  
6 close Docket Number 120052-TP. This docket was opened  
7 to address modifications that needed to be made to  
8 Florida's Lifeline program as a result of the FCC 2012  
9 Lifeline Reform Order.

10           The Commission made the necessary changes to  
11 the program but kept the docket open pending approval of  
12 a permanent waiver request of FCC rules requiring state  
13 agencies to provide hard copy, signed certifications of  
14 Lifeline applicants to eligible telecommunications  
15 carriers.

16           On June 6th, 2014, the FCC granted Florida a  
17 permanent waiver of these rules. Staff believes there  
18 are no further issues to be addressed regarding the  
19 Lifeline Reform Order and recommends that this docket be  
20 closed.

21           Staff is available for questions.
