LIST OF ISSUES AND POSITIONS

St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Preliminary List of Issues and Positions to be taken up at the Hearing now scheduled to begin October 22, 2014 in the above listed docket.

Issue 1: What are the final conservation cost recovery true-up amounts for the period January through December 2013?

SJNG's Position: \$52,833 underrecovery.

Issue 2: What are the total conservation cost recovery amounts to be collected during the period January 2015 through December 2015?

SJNG's Position: An Under-recovery of \$113,557.

Issue 3: What are the conservation cost recovery factors for the period January 2015 through December 2015?

SJNG's Position: \$0.23810 per therm for RS-1, \$0.15181 per therm for RS-2, \$.11480 per therm for RS-3, \$.11064 per therm for GS-1, \$.04696 per therm for GS-2, and \$.02125 per therm for FTS-4.

Issue 4: What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG'S Position: The effective date should be January 1, 2015.
