

This is to advise that Equity LifeStyle Properties, Inc., ("ELS") currently is taking steps to address Department of Business and Professional Regulation ("DBPR") mobile home park rules prior to charging rates for utility services provided by COL Utility Systems, L.L.C. ELS expects to have the DBPR process finalized by January 1, 2015, and then expects to begin charging rates in the community by approximately February 1, 2015. Per Florida Public Service Commission rules, ELS also will prepare a final notice to send to the customers prior to beginning to charge rates.
