5 Item 9 is the petition from Duke Energy
6 Florida requesting approval of modifications to its
7 as-available purchase tariff and interconnection
8 agreement which applies to qualifying facilities that
9 sell energy to Duke on an hour-by-hour basis pursuant to
10 Rule 25-17.0825, *Florida Administrative Code*.

11 The proposed modifications add clarity,
12 provide certainty to both the utility and the qualifying
13 facility, and ensure the tariff complies with Commission
14 rules. Therefore, staff believes the proposed
15 modifications are reasonable and recommends approval.

16 **CHAIRMAN GRAHAM:** Commissioners, any further
17 questions of staff on Item Number 9? Seeing none, I'll
18 entertain a motion.
