Re: Docket 130194 -- Application for staff-assisted rate case in Lake County by Lakeside Waterworks, Inc.

Dear Ms. Stauffer:

In a previous letter, dated September 30, 2014, we expressed our concern regarding the non-arms length contract between Lakeside Waterworks, Inc. (Lakeside) and U.S. Water Services Corporation (USWSC). On Page 4 of our letter under the heading "Market Value", we stated

Because there is no market based on similar bids, we believe that the utility should, at a minimum, provide any contracts (with all Appendices) between USWSC and non-affiliated utilities, especially all smaller utilities with 2,000 or fewer water accounts and 2,000 or fewer wastewater accounts.

The company's response dated October 2, 2014 did not specifically address the above request. In addition, this was not addressed in Staff's Sixth data request (dated October 8, 2014) or the company's response to that request dated October 14, 2014. We believe that it is imperative to compare the USWSC/Lakeside contract to other contracts entered into with non-affiliated companies. This comparison is critically important to help determine if the Lakeside contract is truly at market value.

If the company provides the above contracts, which are the most updated, executed, and complete copies, with all appendices and attachments, it will be possible to compare the scope of services and related costs to determine if the affiliate relationship has caused any increase in costs. If these non-affiliated contracts contain any proprietary information, they can always be provided to staff and OPC on a confidential basis.
