The Office of Public Counsel has requested the supporting workpapers and calculations for the Outside Contractual Services for the U.S. Water Services Corporation contract. HC Waterworks, Inc. (HCWW); Jumper Creek Utility Company (Jumper Creek); and Brevard Waterworks, Inc. (BWW) pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006(3), Florida Administrative Code, requests confidential classification of its response to the Office of Public Counsels request.

The information being requested is "proprietary confidential business information" within the meaning of Section 367.093(3), F.S. This requested information at issues relates to contractual data, such as operations and contract terms, the disclosure of which would impair the efforts of U.S. Water Services (a non-regulated corporation) to negotiate contractual services contracts on favorable terms. The information at issue relates to the competitive interests of U.S. Water Services and its clients, the disclosure of which would impair their competitive businesses. Accordingly, such information constitutes "proprietary confidential business information" which is exempt from disclosure under the Public Records Act pursuant to Section 367.093(1), F.S.

This information should be considered proprietary confidential information in that is (i) intended to be and is treated as private, confidential information by the U.S. Water Services, (ii) because disclosure of the information would cause irreparable harm to U.S. Water Services' business operation, and (iii) the information has not been voluntarily disclosed to the public.
