Andrew and Steve:

Good morning.

I just wanted to follow-up on my telephone conversations with both of you yesterday. As you are aware, my firm represents Crooked Lake Park Sewerage Company ("Crooked Lake") and Glenbrook Properties, LLC ("Glenbrook"). We have been working with the PSC for close to one year to finalize the transfer of majority organizational control of Crooked Lake to Glenbrook. We have dealt with numerous folks at the PSC over that period of time. We responded to many questions and submitted numerous responses and documents. We ultimately made some progress and this matter was placed on the Commission Conference Agenda for tomorrow (12/18/14). Please see attached documents.

Per my conversation with Steve yesterday was the first we learned that this matter should not also include "...name change on Certificate No.517-S to Glenbrook Properties, LLC..." That issue had not come up before since the matter of the name change had been included since the onset pursuant to various correspondence that we received from the PSC. But, we certainly do not want to change the name from Crooked Lake to Glenbrook — and we could not do that anyway. I am not sure why it was set up like that by the PSC.

Per my conversation with Andrew yesterday, he expressed that he needed to hand this matter back to Tom Ballinger to help us address at this point, and thus, I am copying Mr. Ballinger. I am also copying Paul Vickery from whom we previously received various correspondence.

All that said, after the extended period of time, and all of the different folks that we have dealt with, we want to be sure that the matter will still be heard tomorrow...and if that means the agenda needs to be revised to delete the references to the name change...then so be it. We just want it to be clear that Glenbrook is the owner of Crooked Lake – documenting the transfer of majority (actually 100%) organizational control – and the name on the Certificate should remain as Crooked Lake.

Andrew made mention of a conference call today to further discuss this matter. I am not sure who needs to participate in it (including I am not aware of the PSC attorney currently assigned to this matter), but I will certainly make myself available for a call. Please let me know.

We have come a long way on this over a long period of time and it is important to my client that we bring some closure to this.

Thank you for your attention to and assistance with this matter.
